

OFFICIAL CONTEST RULES AND REGULATIONS

TLN presents the: MY FAIR WEDDING BRIDAL REGISTRY CONTEST

Jan 27, 2012

(1) Agreement: These rules govern the TLN "My Fair Wedding Bridal Registry" Contest on TLNTV.COM. Before entering the Contest, each entrant must review and be subject to the Contest Rules. No purchase is necessary to enter the Contest. The act of entering the Contest constitutes acceptance of the Contest Rules and the decisions of the Contest Judges. All decisions of the Contest Judges are final. The Contest Rules may be found at tlnv.com (the "Website").

(2) Sponsors: The Contest Sponsor is Teletatino Network Inc. ("TLN TV" or "TLN").

(3) Eligibility: The Contest is open to all residents of Ontario, 19 years of age or older, except for employees or contractors, immediate families and anyone living with any employee of the Contest Sponsors or their corporate affiliates, advertising or promotional agencies or affiliates. Incomplete or illegible entries, bulk drop offs, photocopies, scanned copies, facsimiles or other mechanically or electronically reproduced entries will not be accepted and will be disqualified.

(4) Contest: The Contest period runs from 9:00 a.m. EST, Saturday, January 28, 2012 to Midnight EST, Thursday, June 28, 2012 (the "Contest Period"). There will be a total of five (5) prizes. The random draw of all eligible entries for the monthly prizes (the "Prizes") will be on the last Friday of each month as follow February 24, March 30, April 27, May 25 and June 29.

(5) How to Enter:

Step 1: GO TO TLNTV.COM AND REGISTER – Go to tlnv.com and register for the TLN "My Fair Wedding Bridal Registry" Contest from January 28, 2012 to June 28, 2012

Step 2: COMPLETE THE ONLINE SUBMISSION – Go to tlnv.com and submit your information.

Step 3: RETURN EACH MONTH TO INCREASE YOUR CHANCES– During the "Contest Period" return to tlnv.com monthly and complete the form. Monthly entries (1 entry per person per month permitted) will increase odds of winning depending on the total number of entries received.

The Contest Sponsors are not responsible for late entries and no entries will be permitted before or after the "contest period". Only one entry per person is permitted per month. The odds of being selected as a potential winner depend on the total number of eligible entries received. In order to win, the potential winner must also correctly answer a mathematical skill-testing question.

The potential winner will be contacted on Monday after the draw, by telephone at the daytime number recorded on their entry, during regular business hours.

If the potential winner cannot be reached within 48 hours from the time of initial contact by a representative from the Teletatino Network Inc., an alternative entry will be selected until such time as a potential winner satisfies the terms of this section.

(6) Prize: There will be a different prize each month. The prize is non-transferable and has no cash value. The winner will receive the prize from Telelatino Network Inc. If the winner is unable or unwilling to claim the "Prize" within 2 days, for any reason, the next eligible entry selected by random draw will be contacted and the first entrant will have no further claim to the "Prize." The "prize" must be redeemed at Telelatino Network's offices located at 5125 Steeles Av. West, Toronto, ON M9L 1R5, a valid photo ID will be required. The Contest Sponsors may, but are not obligated to, mail or courier prizes, and are not responsible for unclaimed prizes.

(7) Privacy: We will use personal contact information to administer the Contest, including contacting, announcing and promoting prize winners. Winner information will be disclosed to the prize provider for fulfillment.

(8) Banning: The sponsors may, in their sole discretion, prohibit any person from entering any contest whom they believe to be abusing the Contest Rules. Such abuse includes entering false information and entering more than one entry per day.

(9) Declaration and Release: Prior to receiving the prize, the winner will be required to show valid photo ID, must sign a declaration of eligibility and compliance with the Contest Rules. The winner will be required to sign a release and consent to publicity form, releasing and indemnifying the Contest Sponsors and their respective parent(s), subsidiaries, affiliates and/or related companies and each of their officers, directors, shareholders, employees, advisors, assignees, agents, licensees, representatives, advertising, media buying and promotional agencies from any liability in connection with the Contest and/or the Prizes, including but not limited to injuries, death, damages or losses of any kind resulting from the Contest, including but not limited to acceptance or use of the Prize. Prior to receiving the Prize, the prize winner shall each agree to have his/her name, city of residence, photograph, voice and/or image used in any and all forms of media, without further compensation by the Contest Sponsors and/or their advertising and promotional agencies. If the Telelatino Network Inc. representative does not receive the signed form as contemplated herein, back within 48 hours, then Telelatino Network Inc. may draw for another potential winner and the first winner will have no further claim to the prize.

(10) General: The Contest Sponsors reserve the right in their sole discretion to cancel, suspend or modify the Contest or the Contest Rules at any time without notice. All prizes must be accepted as awarded, are non-transferable and are not convertible to cash. All prizes are awarded as is and no warranties or guarantees are implied or expressed, beyond standard warranties. Contest Sponsors are not liable for any errors or negligence that may arise in connection with this Contest or the Prize. The Sponsors reserve the right to substitute any prize with a prize of equal or greater value. The Contest Sponsors are not responsible for lost or misdirected or late or ineligible entries. Winner must be willing to accept prize delivery upon Contest Sponsor's terms and delivery times.

(11) Subject to Applicable Laws: This Contest is governed by and subject to all applicable federal, provincial and municipal laws and regulations and is void where prohibited. This Contest is governed by the laws of Ontario and the laws of Canada applicable therein. By participating in this Contest, entrants agree to be bound by these Contest Rules and the decisions of the Judges in awarding the prize, which decisions shall be final and binding upon all entrants. Failure to comply with these Contest Rules may void the entrant's rights to any Prize. Interpretation of these Contest Rules by the Contest Sponsors shall be final and binding.
